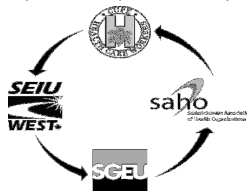

<p>Working Relationships</p> <p>Has regular contact with clients and families requiring tact and discretion when dealing with special needs.
