<p>Performs sonography testing and assesses results to ensure quality and service requirements are met. Inaccuracies and misjudgments in testing can result in substantial delays in patient's diagnosis and treatment. Misjudgments in applying pressure when testing may result in physical discomfort for the patient. Misjudgments when selecting which images to take and to keep may mean that the optimum images are not available for the physician or radiologist/cardiologist to view and interpret, thus delaying diagnosis and treatment.</p>	<u>3.5</u>
<p>Leadership and/or Supervision</p> <p>Provides occasional guidance to staff and students. Provides functional guidance when interpreting and explaining policies and practices associated with testing.</p>	<u>2.5</u>
